Program Updates:

Reminder: This year’s Seniorama event will take place on 5/2/26. Nominations are requested by 3/13/26. March Site Activities include Nutrition Feud with the Registered Dietitian, “Making Meals with Pantry Items” presented by Cornell Cooperative Extension, presentations by the NYS Parks Naturalist, Hooked on Music, and WISE (Wellness Initiatives for Senior Education).

Livingston County Office for the Aging is partnering with AARP to offer Safe Driver Training on March 24th at the Conference Center.

The agreement with Genesee Valley Rural Preservation Council (GVRP) for the Wildbriar Senior Site is in the process of being renewed. There is no payment to GVRPC. The contract outlines the terms and conditions for the Senior Site at Wildbriar. GVRPC provides the space at no cost, and funds the staff position. The Site has exceeded expectations. It is averaging over 20 meals per day and almost 60% of participants are from the community (not residents of Wildbriar Housing).

Pre-approved Informational Item(s) To Be Reported

- A. Occupancy: As of February 23, 2026 we have 260 residents in-house and 3 residents in the hospital for an occupancy of 98.0% for February. Year to date occupancy is 97.2%.
- B. Cash Flow: The LCCNR's total cash flow-cash reserves as of February 23, 2026 is \$ 2,458,237.32.
- C. Judy Seier, CFO will present financial information.

Ms. Spencer gave a brief overview of the census, occupancy and cashflow. Ms. Spencer reviewed highlighted items below. Ms. Spencer explained that the Item A medication error was by a supplemental staffing nurse who was removed from the roster immediately. Deputy director interviews start this week and the CFO candidate plans to start on 3/16. Mr. Seier gave an overview of the financial statements for January 2026.

Informational Item(s) Written Only

- A. The CNR was fined \$10,000 resulting from the harm level medication error in October of 2025. As a result, our CMS overall rating dropped by one star and our quality measures rating dropped by one star.
- B. The Plan of Correction (POC) was submitted to DOH on February 20, 2026 for the recertification survey exit date January 28, 2026. There were 11 total citations, 2 physical plant citations and 9 health citations.
- C. Special Care System: The wanderguard project system upgrades were completed on February 23, 2026. However, two change orders are pending related to three uncovered doors and the work is scheduled to start during the week of March 9, 2026.
- D. The CNR is working with Ryan Snyder, Wyoming County Nursing Home, and BOCES to secure funding for the LPN program. We're working to start a class in July of 2027.
- E. The six-week certified nurse aide training class started on February 25, 2026 with 16 students enrolled.
- F. The Garden of Life (GOL) adult day care program has a census of 13 participants with 2 pending admissions.
- G. There were 3 self-reported incidents to the DOH since the last HSC meeting.
- H. The CNR team continues to work more to optimize skilled coverage through Beacon Solutions guidance. Focus remains on Admission process and capturing Medicare (MCA) coverage to increase revenue. Contract ends at the end of February 2026.
- I. Beacon Solutions Group continues working with the CNR to ensure billing functions are completed. Accounts reviewed monthly to ensure payments to CNR are occurring. Processes implemented for payment plans.
- J. OnShift (Staff Scheduling Software): In the negotiation phase of contracting. Software will help the CNR monitor staffing levels to ensure adherence with budgeted hours, streamline the scheduling process, and provide instant access to overseeing overtime hours which has potential to control costs.
- K. Updated information for the VAP grant was sent to DOH as of October 27, 2025. Receipt confirmed on October 28, 2025, and the application is pending review.
- L. The Office of Medicaid Inspector General (OMIG) exit conference occurred on August 7, 2025. Estimated overpayment from January 1, 2018 through December 31, 2021 is \$1,022,840. This included the following disallowances: mortgage interest, moveable equipment rentals, other, and dialysis costs. Bonadio Group assisted CNR in appeal process and items that CNR will appeal which amounts to roughly \$318,000. Appeal occurred on October 20, 2025. CNR pending receipt of the Final Audit Report.
- M. Performant (OMIG Agent) completed an audit of Medicaid claims paid to the CNR for LTC services for the time period of March 1, 2020 through December 31, 2024. This included a total of 420 overpayment claims, resulting from incorrect NAMIs applied to claims, bills for service dates after discharge, and incorrect claim payments based on patient Medicare eligibility. Appeal submitted on December 8, 2025. The facility is disputing \$953,550.02 (396 claims) of total balance of \$955,461.21, and agreeing to \$1911.19 (24 claims).

2. **PROCLAIMING THE WEEK OF APRIL 6–12, 2026 AS NATIONAL PUBLIC HEALTH WEEK**

WHEREAS, the week of April 6-12, 2026, is National Public Health Week and the theme is “Ready. Set. Action!”; and

WHEREAS, since 1995, the American Public Health Association, through its sponsorship of National Public Health Week, has educated the public, policymakers and public health professionals about issues important to improving the public’s health; and

WHEREAS, from 2019 to 2021, life expectancy in the United States fell from 79 to 76, which is the largest decrease over a two-year span since the 1920’s; and

WHEREAS, there is a significant difference in health status, such as obesity, poor mental health and drug use, among people living in rural areas compared with people living in urban areas, and this variance increases because rural residents are often more likely to face social determinants that negatively impact health, such as poverty, transportation barriers, and lack of economic opportunity; and

WHEREAS, a person’s health status can differ drastically by zip code due to differences in the built environment, environmental quality, community context, access to healthy food and access to education and health care; and

WHEREAS, public health professionals help communities prevent, prepare for, withstand, and recover from the impact of a full range of health threats, including disease outbreaks such as the COVID-19 pandemic, measles, natural disasters and disasters caused by human activity; and

WHEREAS, public health action, together with scientific and technological advances, has played a major role in reducing and, in some cases, eliminating the spread of infectious disease, and in establishing today’s disease surveillance and control systems; and

WHEREAS, preventable risk factors such as physical inactivity, poor nutrition, tobacco use, and excessive alcohol use are leading causes of chronic disease. 6 in 10 U.S. adults have a chronic disease and 4 in 10 have two or more. Chronic diseases cause 7 of every 10 deaths annually in the United States; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby proclaims the week of April 6-12, 2026, as National Public Health Week in Livingston County and the residents of Livingston County are hereby asked to observe this week by helping families, friends, neighbors and co-workers to better understand the value of public health by supporting great opportunities to adopt preventive lifestyle habits in light of this year’s theme, “Ready. Set. Action!”

- One clerical staff member in the Mental Health front office has submitted her intent to retire at the end of February. We are actively recruiting for this position and have a potential hire.
- In January, Environmental Health staff completed 26 food service establishment inspections, 19 rabies investigations with 1 positive racoon, 3 migrant farmworker housing inspections, and 1 municipal community public water system sanitary survey.
- CSHW staff saw 42 patients in January. SUNY Geneseo clinics are back in session for the Spring semester, with clinics held Tuesday afternoons and all day on Friday's. Our corrective action plan following the IPRO audit has been submitted and officially accepted.
- Hospice served 37 individuals in January. They received 22 referrals and admitted 17 patients. We worked with patients at Morgan Estates, The Teresa House, Noyes Hospital and some in home.
- The Health Education team is providing a Collective Impact training to the Genesee Valley Health Partnership on March 12th as 2:30pm at URMN Noyes Hospital.
- The Positive Expressions group locations have been updated. They will now be in Livonia on Mondays and Avon on Tuesdays. The Community Center of Geneseo date is still being determined. The Dansville location has been discontinued. There were 78 attendees at the January Positive Expressions groups.
- PICHC staff began the Thrive After Birth Learning Community, a continuous quality improvement initiative focused on improving postpartum visit attendance rates.
- PH Emergency Preparedness staff are preparing for a full-scale exercise Medical Countermeasure drill that will take place on March 20th.
- Immunization staff administered 6 vaccines to 3 different clients in January.
- 102 communicable disease reports were received in January. 57 reports were investigated and 30 new cases were reported to HCS. (13 blood borne reports, 3 Hepatitis A reports, 42 Hepatitis C reports, 18 Hepatitis B reports, 2 perinatal Hepatitis B reports, 10 enteric reports, 56 STI reports, 5 VPD reports, 1 vector borne report and 5 TB reports)
- Early Intervention received 14 new referrals in January and opened 9 new cases. As of 2/13/26, the EI waitlist has 25 services for 21 children waiting for providers.
- As of 1/31/26, Livingston County has 8 active elevated blood lead level cases and 12 open environmental work plans. Lead program staff has been working closely with Keshequa Central School District and local doctor's offices regarding the lead exposure in the drinking water at Keshequa Central School.
- WIC is currently recruiting for a WIC Program Nutritionist.
- Fiscal staff billed \$499,300.00 in claims in January and received \$409,996.00 from previous months billings.

4. The WNY Children’s Advocacy Network, Marcie & Brad Prinzi have been working with Commissioner Tracy McCaughey, District Attorney Ashley J. Williams & Sheriff Thomas J. Dougherty to establish a Child Advocacy Center in Livingston County. The purpose of a Child Advocacy Center is to provide streamlined, child focused services for victims of abuse and neglect. A Gala is being held on March 20, 2026 to help raise money to support this endeavor. A copy of the flyer will be distributed at the meeting.
5. In the month of January, 20 staff members participated in "Friday Night at the ER" simulation led by Kelly Greenway. The program was highly recommended and will be rolled out to the rest of DSS staff throughout the coming year. We also began the Positive Intelligence for PQ-Powered Teams program led by our consultant Jill Peterson of Clover Insights. This program involves 16 staff members in leadership roles across the department participating in several weeks of training with a goal of strengthening leadership and team effectiveness. Staff Development also hosted an in-service with Mary Jo Acomb from Hillside to inform staff of services offered that could be beneficial to clients. Monthly consultations continued with Denise Krause and Jill Peterson, with 17 staff members engaging in individual sessions to promote professional development.

Commissioner McCaughey serves on the NYPWA Board of Director’s and attended a strategic planning meeting February 25-27, 2026.

1. SUPPORTING OPERATION GREEN LIGHT FOR ACTIVE MILITARY SERVICE MEMBERS IN TRANSITION TO CIVILIAN LIFE (VETERAN STATUS)

WHEREAS, approximately 200,000 service members transition to civilian communities annually and there is expected to be an estimated 20% increase in service members that will be transitioning to civilian life in the near future; and

WHEREAS, studies indicate that 44% - 72% of service members experience high levels of stress during transition from military to civilian life. Sadly, active military service members transitioning from military service are at a high risk for suicide during their first year after military service; and

WHEREAS, the Livingston County Board of Supervisors appreciates the sacrifices our United States military personnel make while defending freedom and believes specific recognition should be accorded them in appreciation of their service; now, therefore, be it

RESOLVED, that the Livingston County Board of Supervisors hereby declares Livingston County a Green Light for Military Service County from October 14, 2026, through November 13, 2026. This is a time to salute and honor our men and women in uniform making the transition from active service to civilian life by switching one lightbulb to green to show visible support for veterans; and be it further

RESOLVED, that the Livingston County Board of Supervisors hereby acknowledges the inception of Operation Green Light created in this County is now nationally recognized through the National Association of Counties from November 4-11, 2026 and supports our nations endeavor to recognize Operation Green Light; and be it further

RESOLVED, that as a Green Light for Military Service County, the Livingston County Board of Supervisors hereby pledges to support Onward Ops Military Transition Support formerly known as the Expiration Term of Service Peer Mentorship Program (ETS-SP) that connects mentors to new veteran residents; and be it further

RESOLVED, that in observance of Operation Green Light for Military Service, the Livingston County Board of Supervisors encourages its citizens to recognize the importance of honoring all those who made immeasurable sacrifices to help to preserve freedom by displaying a green light in a window of their place of business or residence. Green is the color of hope, renewal and well-being. The simple action of changing one light to green can spark meaningful conversation regarding the recognition of veterans and help “green light” them forward as valued members of our communities.
